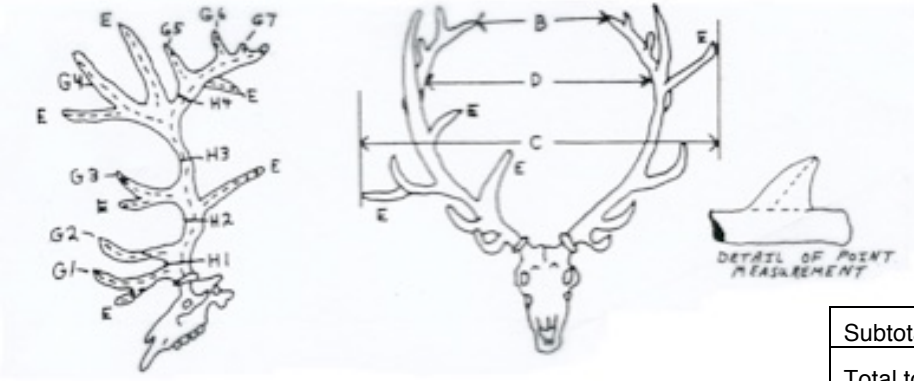

FAIR CHASE STATEMENT**

To be eligible for recording, the trophy animal must be taken in complete compliance with the game laws of the province and according to the rules of "Fair Chase".

Fair Chase as defined by the SWF Henry Kelsey Big Game Records Committee, is the ethical, sportsmanlike and lawful pursuit and taking of any free-ranging wild game animal in a manner that does not give the hunter an improper or unfair advantage over such game animals.

Use of any of the following methods in the taking of game shall be deemed Unfair Chase and unsportsmanlike:

1. Spotting or herding game from the air, followed by landing in its vicinity for the purpose of pursuit and shooting;
2. Herding, pursuing or shooting game from any motorboat or motor vehicle.
3. Use of electronic communication devices to guide hunters to game, artificial lighting, night vision optics, sights with built in electronic range finding capabilities, thermal imaging equipment, electronic game calls or cameras/timers/motion tracking devices that transmit images and other information to the hunter.
4. Hunting game confined by artificial barriers including escape-proof fenced enclosures or hunting game transplanted solely for the purpose of commercial shooting;
5. Taking of game in a manner not in full compliance with the game laws or regulations of the federal government or of the province or tribal council on reservations or tribal lands;
6. Or as may otherwise be deemed unfair or unsportsmanlike by the Advisory Committee of the Henry Kelsey Big Game Records.

I certify that the trophy scored on this chart was taken in Fair Chase as defined by the SWF Henry Kelsey Big Game Records Committee. In signing this statement, I understand that if this entry is found to be fraudulent, all of my prior entries are subject to deletion from the Henry Kelsey Big Game Records and future entries may not be accepted.
