Use of any of the following methods in the taking of game shall be deemed Unfair Chase and unsportsmanlike:

- 1. Spotting or herding game from the air, followed by landing in its vicinity for the purpose of pursuit and shooting;
- 2. Herding, pursuing or shooting game from any motorboat or motor vehicle.
- 3. Use of electronic communication devices to guide hunters to game, artificial lighting, night vision optics, sights with built in electronic range finding capabilities, thermal imaging equipment, electronic game calls or cameras/timers/motion tracking devices that transmit images and other information to the hunter.
- 4. Hunting game confined by artificial barriers including escape-proof fenced enclosures or hunting game transplanted solely for the purpose of commercial shooting;
- 5. Taking of game in a manner not in full compliance with the game laws or regulations of the federal government or of the province or tribal council on reservations or tribal lands;
- 6. Or as may otherwise be deemed unfair or unsportsmanlike by the Advisory Committee of the Henry Kelsey Big Game Records.
