

## National Archery in the Schools Program (NASP) - Doug Gibson, Director of NASP Programing

- In Saskatchewan we have a little over 200 schools participating with 20,000 participants. Grade 4 Grade 12 participate together. Youth with disabilities, learning disorders and confidence issues participate.
- Basic Training Full Day. 17 instruction courses 70 teachers & volunteers took this training.
- Provincials Yara, Moose Jaw: 65 schools with 869 archers male 484, female 385.
- Canadian National Tournament was held in Evraz Place, Regina: 966 archers/735 3D side, 77 schools.
- Grants NASP awards grants to new schools: total of \$10,000. Equipment replacement grants \$750-\$1000 each.
- 2020 Provincial Tournament is in Melville April 4 & 5.
- 2020 Canadian National Tournament Bulls Eye and 3D back to back. April 24-25.
- Lots of changes coming down so please contact me with questions.
- Thanks to everyone. Your support literally may have changed a child's life.

#### **Open Question Period**

Greg Illerbrun – Internet page and membership. Need to explore that. Could we sign them up as provincial members and then pass them on to the branches for the next year? We need to plant trees at Federal gov't expenses.

Lorne Scott - What is happening on the FWDF land by Indian Head (destruction of habitat). Not sure of the outcome yet. Fencing – we pulled his lease. Ongoing for two years. Cost of fencing - \$171,000. Cost recovery from the lease. Spending this much on fencing – is it worth it? Not budgeting anything right now. Was a government policy, changed some of the policy somewhat now.

Jack Tweitmeyer - Sit on board of Upper Souris Watershed. Would like to ask the Minister when we find mussels in our waterways what is the plan? We should make it law that any water craft into our province has to be checked. Have to get on this. AIS is a concern and we need to get serious about this.

Shauna Stanley - we share everything that SWF posts. Membership - online memberships please just do it, look at the model that a political party uses. Our communities are not as connected as they used to be.

Joyce Lorenz - What are we going to do with the old canoes? Replaced 14 canoes. Increase our footprint in the south, many discussions with Scouts Canada who have 44 properties in Saskatchewan and we are dealing with them right now. Hope to negotiate with them, and canoes will be used there.

Matt Schidlowsky, Humboldt - Concern with how often branch profiles are updated.

## **SWF Executive Director's Report – Darrell Crabbe**

- Challenges and opportunities we have in front of us in 2020 and 2021.
- Corporate Structure.
- Staffing: restructuring staffing. Using existing staff and contracting staff. Hatchery group negotiated three-year agreement.
- Great North Wildlife Affiliates, Hannin Creek Education Research Centre, Sask Wildlife Assets Management (Hatchery).
- Membership: right across North America club membership (volunteers) are declining. We have plans to buck this trend. Priority to work on an online membership option difficulty is to customize it for individual branches.
- Advancing Women in Conservation demographics in our membership younger than we thought 35% are females. Have to look at a different system to urge women to get more involved in taking more leadership roles.
- Branch Rejuvenation Program: seminars and Q&A. Explain the benefits, SWF programs, get involved in the local branch.
- Future Challenges: Number one funding. Over 90% of money raised is on the backs of hunters/anglers/trappers from their licenses and work. Expand the financial participation of the non-consumptive users. USA does an excellent job of this.

- Youth Conservation Camp: Report on 2019 camp. 63 campers 2 boys camps / 1 girls camp. Donation from Touchwood Hills branch for 15 new canoes. Murray Doell winners Emily Kaplin, Tisdale; Owen Booth, Witchekan; Chet Saretzky, Bruno.
- W.O.W. very successful. Had 30 participants, started a waiting list last year.
- Youth Conservation Leadership Program: Stage 1 Weekend wilderness. Stage 2 job opportunities. Community Outreach.
- Bigfoot Snowshoes Repaired 70 pairs and bought 50 more pair. In very high demand.
- Geocaching We have 20 to 25 out there. Brings in people from all walks of life. Putting out more in 2020.
- Classrooms in a Box Grades 4 to 6.
- Posters 15 posters. Last poster was bottom feeders, next will be minnows and friends.
- CWF Canadian Conservation Corps 15 participants volunteered @ SWF. Stage 1-Survival Training and Leadership. Stage 2-Home- work projects. Stage 3 Help promote SWF programs. Brings people together across the country.
- Wonders of Wildlife manual reprint back by popular demand.
- Sporting Clay Shoot will hold another one in July.

## Friday, February 21, 2020 - page 4 (MOE Enforcement, Compliance & Field Services Branch cont'd)

- Detective Sergeant Chris Clarke UC Study Special Investigations. Taken down 3 files -\$162,000 in fines in the last 3 months. Total fines in last three years-\$350,000. Undercover operation- Trafficking in Bear parts @ Sandy Bay- 3 year undercover. Covered Sandy Bay, Saskatoon, Toronto.
- Sergeant Ted Glass: Control Wildlife Models. The decoys designed to look like wildlife. Safety violation, predispositions (has to be a history), homework/leg work, location has to be safe for anyone in the area, operation is reviewed. Constantly assessing operation for safety, for the officers and the violator, this is very important Target specific. Safe, efficient & effective.

#### **Open Question Period**

- Control Wildlife Models: How is this not considered entrapment? We never put our large trophy animals in an area where an ethical hunter could shoot it.
- Do you have a data base for offenders so you discover if they are reoffending? Yes, we do so you can present their past history.
- Sandy Bay and Saskatoon- are they still operating restaurants. Yes, no repercussions to their businesses.
- Any info re: offenses of people shooting cattle. Unfortunately, we have not received any tips.
- PRT What kind of fines-break and enter/domestic issues-everything turned over to RCMP and not aware of the prosecutions.
- Ituna area Guided moose hunters-they say they have the rights to hunt there and are keeping others out. First Nations are involved in commercial outfitting on their land. Allocations/ export permits. Most are doing a good job.
- What are the legalities dealing with animals considered not native to our area? Landowners have the right to protect their livestock.
- PRT-Does it have an impact on rural crime? Yes, it does show that it has. Alberta is considering moving ahead with this.
- Fines, were they out of pocket re: gall bladder? Yes, fines were \$6700.
- What did you do with the money you received from the sale of gallbladders? Turned back in to fund our projects.
- Renting land from the landowners in the fall and putting up No Hunting signs. Keep the conservation officers in area informed.
   Tough to prosecute.
- Low caliber rifle in two years. Any statistics. Really don't have anything to track that, if you have concerns please talk to your MLA
- Trespassing Act: Not proclaimed.
- When guns taken away, why are they given back? Trucks, guns, hunting equipment should be forfeited and sold. Depends on what the infraction is and due to the mentality in Canada, firearms have to be destroyed.
- Trespassing Nothing to do with wildlife, goes to the RCMP. Why isn't the PRT involved? So circumstantial. Usually 911-crimes in progress.
- RCMP are they trained to dispatch a wounded or sick animal? Their primary response is public safety.
- Manitoba First Nations Preeceville, Sturgis, Canora landowners pretty distraught re traffic through their standing crops. Moose shoot in their yards at night. The whole east side problem areas. We do have some plans next fall.
- Three moose shot on neighbour's property land was posted, license plates taken, and charges laid but nothing happened.
   Prosecution up to judges.
- Can they transport the meat back to Manitoba (CWD)? As far as the transport of meat, it is up to Manitoba. We did bring in officers from the north and south in the south-eastern part of province.
- PRT- see it as a tool to use our Conservation officers. First Nations Manitoba shot 9 moose, only took 8 moose. Cannot understand how they get away with this. Not sustenance hunting, getting paid for guiding.
- Management of FWDF Lands New signs. Vehicles parked on Wildlife Lands it was reported and nothing was done need to get on the same page. How the laws are enforced is certainly circumstantial.

## Hannin Creek Education & Applied Research Centre - Shannon Anderson/Dwayne Davison

- Joint ownership Sask Poly/SWF since 2015 camp at Candle Lake.
- SWF runs the camp and rents it out.
- Camp is staffed by employees and staff and in 2019 we had 619 guests and 118 days of occupancies.
- \$40,000 Cabela's Outdoor Fund Grant.
- We need volunteers to make this happen. A lot of credit goes to Jim Kroshus and Phil Haughian.
- We have work bees to help with the upgrades and repairs. Volunteers are welcome.

#### University of Regina Sport Fish Tagging Program - Dr. Chris Somers

Objective Sport fish we value and to keep the population viable. Establish a population of marked fish. Long-term recapture database. Important activity - science of fisheries management is very important.

- Fisheries is a very important to us as a province, financially and culturally.
- Context of management Catch and Release.
- Active tagging to put a tag on fish is resource intensive fish transports information. Device in water listens and uploads information, reports data. Doing this for the last 3 years on Buffalo Pound Lake pike, walleye and burbot.
- Passive tagging put tags on and angler reports. T-Bar tags walleye, pike and yellow perch. Started in 2017. 8500 fish tagged.
- Watch out for those tagged fish.
- Competitive fishing events: Riverhurst 9 tagged fish from Diefenbaker caught and reported 2 times and 1 fish caught and reported 3 times. Others that were tagged at Riverhurst were caught 100K from where they were originally tagged

## Prussian Carp – Shayna Hamilton

- Common Carp has whiskers and Prussian Carp has no whiskers.
- Established in the province in 2018. Two main objectives where are they in SK, what food do they use and what native population will they be competing with? They reproduce very quickly. Compete with food spaces.
- Most invasive fish species in Europe and competes with native species.
- While looking for Prussian Carp were able to study some of the different fish in the province.
- First introduced in Alberta and first detected in Swift Current Creek
- Most important data we have is from citizen science 80% of our distribution locations in our database are from citizen science.

## How Old are Cisco? - Linnea McLellan

- Healthy walleye population is linked to a healthy cisco population.
- Analyze scales count bands to determine age of fish. Use growth pattern, light band is from summer and darker band is from winter. Cisco are growing old in our water systems. Wide range that are susceptible to winter fishing.

### Genetics of Hatchery Brood Stock - Ryder Rutko

- Three main species looked at for the study: brook, brown and rainbow trout.
- Is there genetic diversity. Yes, in brook trout and rainbow trout still diversity however only one strain in the brown trout.
- Origin used DNA Barcoding. Looked into where the original brood stock was from. Rainbow/brook have not become
  genetically homogenized due to captive breeding.

#### Canadian Wildlife Federation - David Pezderic

- David brought greetings from CWF.
- Two members from Saskatchewan sit on the CWF Board.
- Truly a Canadian conservation charity inspiring action to protect Canada and wildlife.
- Overview of all CWF programs.

- 56 different stock waters reports from 41%.
- Success of harvest 63%. Average 2.1 trout and 1 hour to catch trout.

## Aquatic Invasive Species (AIS) – Jeri Geiger, Invasive Species Coordinator, MoE

- Non-native organism with potential to out compete native species when introduced. Harm ecosystems damage to shoreline, infrastructure.
- 19 species are listed. Number of plants listed also.
- All efforts put into prevention education, partnerships. Provincial/partnerships/research/trans-boundary.
- Four Pillars: Prevention; Early Detection & Surveillance; Rapid Response Plan; Management & Control.
- Watercraft Inspection program;7 decontamination units.
- Early detection rapid response plan

#### Lanigan Creek - Brad Uhrich, Ducks Unlimited

- Lanigan Dam/Last Mountain Lake structure went up in 1969 50 years old and end of life
- Difficult for fish to get upstream
- Arm River Dam Smith project and Ridell project

- Brian Kerchuch, Executive Director Wildlife & Lands introduced the presenters:

## **Update on Game Management Plan Objectives** - Joann Skilnick

- You contributed to the development of this plan. In the future people can pick up this plan and know what our plans were for the wildlife populations in this province.
- 10-year plan can go back to see if we are achieving our goals.
- Based on Fish Management Plan & ten species.
- Three main outcomes in the plan-Sustainable management; Transparent Game Allocation Framework & establish a two-year cycle; Shared responsibility in public engagement in wildlife management.
- Engaged with First Nations
- HABISASK App. FWDF lands are listed here.
- Clear framework for our plan. Review and update language.

## **Chronic Wasting Disease Update - Todd Whiklo**

- 2018/19 2000 samples 349 positives: 24 whitetail; 270 mule deer. 91 management zones.
- GIS CWD application/public interface.
- New diagnostic contract-PDS Prairie Diagnostic Services.
- 2019/20: 3561 samples 1 moose, 5 elk, 78 WT, 379 MD tested positive.
- Management Challenges/ Carcass Disposal/ One Health Approach and become more efficient with the resources we have. Increase budget and public education. Moratoriums on new Game Farms.
- History of this disease shows that deer populations decline, resulting in a decrease in hunting opportunities.

#### Harvesting Big Game Lymph Nodes - video being created with SWF & CWD technicians

- Hunter tissue samples most done well, easier to transport. Some issues incorrect tissues, packages without proper info, packaging was a big one for sure. Please put in hard plastic containers. Samples so much better when taken immediately.
- Tissue sampling workshop. Cost and time saving when taken by hunter.
- Video shown.

## **<u>Hunter Education Verification Audit</u>** - Travis Williams

- Audits 4 types Positive; Exceeds more than legislation requires; Type 1-Does not pose a threat to health & safety; Type 2-Corrective action plan to come into compliance; Type 3-Action to take place immediately.
- Determine if people are purchasing licenses without the required certification. Info taken from HAL/SAFE
- Letters will be sent out to those that are non-compliant. 213 hunters were randomly chosen. No final numbers at this time.
- Continue to manage on a provincial basis.

## **Hunting and Angling Licensing System - Matthew Weiss**

- Reported on 2019 Big Game Draw. Small increase in number of applicants.
- Legacy Pool went down slightly last year and slightly up this year.
- Unpurchased licenses -3500 draw licenses not purchased. Trying to figure out why.
- Majority drawn for one species, not that many drawn for three species.
- Veteran hunting and angling licenses issued. 848 registered to date.

## Mandatory Reporting - Katherine Conkin / Matthew Weiss

- Hunter Harvest Survey and the importance of sample size more data supports better decisions.
- 28 different license tag surveys. Surveys available 116,148; surveys completed 24,568
- Completed 2017 28%; 2018 25%; 2019 21%. Non-resident WT 59%
- Try to make it easier. Education and information.
- Looking at mandatory Hunter Harvest Surveys. Look at it as a responsibility.

#### **Open Question Period**

- Greg Illerbrun CWD Link it to license application. What do you do with the head? Specific set of dumpsters taken to the PA landfill.
- Shauna Stanley Seymore Video is wonderful produce something that is a downloaded link. Yes, will be done.
- Ron Heisler When people are drawn for multiple tags and they turn them back in do they get redistributed? No we do not have a way to do that.
- Tracey Wilson Making hunter survey mandatory what would be the punitive measures/reward them who fill in the survey. Yes, we are looking at that, decisions still being made.
- David Pezderic Why are the heads not incinerated in Saskatoon? Facility in Saskatoon not an incinerator, it is a digester with limited capacity. CWD survey to stakeholder groups, when is this happening? Ministry of Health, Agriculture and Environment and senior levels of government. Depending on the direction of the survey that comes back, actions are well established. Grind to get through this, unfortunately just delays. Hopefully have something in the next 12 to 24 months.
- Ryan Lauf, Sask Bowhunters Cross contamination? Hunters wear protective gear goggles, gloves and sterilize tools with bleach; skin and debone in the field. Butcher shops out of the scope of the department, under the Ministry of Health.
- John Gabruch, Maple Creek- Mule Deer population is exploding. Why do we not have over the counter tags for a few seasons.
   Increased licenses to 1500 licenses. We didn't allocate 1000 licenses. Looking at different measures, we are meeting in next two weeks.
- Richard George, Redvers no cases of CWD in our area. People hunting in other zones and their animals tested positive and they are now using the infected animals for bait. They should be disposed of.
- Doug Gibson, Cut Knife branch Audit re HAL/Hunter Safety. Goal to clean up for draw season. Will this be done prior to the draw? If done after the draw, tags will not be used. Awareness will be helpful.
- Matt Schidlowsky, Humboldt Close offices and then ask SWF branches to help. Could we get help with freezers, generators, etc. Will sit down with branches.
- Todd Smith Lack of funding to FWDF. Free licenses for veterans over \$24,000 did not go into the FWDF. Gov't not planning on putting in the funds.
- Heath Dreger What do we do with our deer hides. Catch 22, illegal to dump these hides. Find an appropriate land fill, bag it
  and dispose of it.
- Joyce Lorenz There should be somewhere that the license seller can look to see if the person does have their HAL/Hunter Safety Certificate. Once audit comes through will see how deep this issue really is.
- Jack Twietmeyer, Souris Moose Creek Audit is for 2018-2020. Took mine in 1962. How far do you go back? If you were born before 1971 you do not need a Hunter Safety card.

#### Workshop – Habitat Trust Lands Access/Signage

- Talk about signage going forward Only Habitat Trust Lands.
- Signs out there right now 1247. These lands are considered PRIVATE LANDS/under the trespass lands act.
- Do restrict access on these lands now.
- Access on Foot Only-except to retrieve game and management work.
- Seeking your input on how you want your lands accessed.
- All other lands will be closed so the Trespass law will put increased pressures on accessible wildlife lands.
- SWF members already have written permission on membership cards so will be non-member access.

- Hunting on Foot Only will allow year-round hunting access to first nations.
- Assume the act will come into proclamation by 2020 Hunting Season.

- Pros & cons of members-only accused of having hunting preserves.
- Pros & cons of a program allowing non-members access. Extremely short time-line.
